

# PRIVACY STATEMENT regarding the "HUAWEI SEEDS FOR THE FUTURE" Program

## What is the purpose of this Privacy Statement (the "Statement")?

This Privacy Statement gives you information about the personal data we collect about you in relation to the "Huawei Seeds for the Future" Romania and Moldova Program 2023, which includes the 8-day program (the "Event"), and how and for what purposes we process your personal data.

The "Seeds for the Future" Program, developed by Huawei, started in 2008 and is currently running in 139 countries on all continents, including Romania. The program is aimed at students and young graduates interested in the ICT field, and its goal is to identify young talents in the technology field and contribute to their training and professional development.

The Event includes presentations, workshops held by industry experts and Huawei employees, etc.

In Huawei we understand and respect the importance of privacy. This Statement describes how Huawei uses and protects your personal data while organizing the Event and how we fulfil our obligations under Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) ("GDPR").

**How long** will the Personal Data be retained before it is deleted?

We will retain your personal data for the duration of the Event, and for a period of maximum 2 years thereafter. Afterwards, the paper records will be destroyed and the electronic files will be deleted.

For the promotional purposes, including posting the personal data on Social Media, we will retain your personal data for maximum 4 years from collection. Afterwards, we will delete the personal data from our social media accounts (under the condition that we still have control over them). We are not responsible for deleting or intervening in any way over personal data present on any other internet page where the data may be shared and over which we have no control.

## Transfer of Personal Data out of the European Economic Area (EEA)

Personal data will not be transferred out of the EU/EEA by Huawei. Please note that by posting personal data to Social Media, the personal data may be transferred to third countries, subject to the Social Media website owners' privacy policies.
